BY-LAW NO. 136 A BY-LAW TO LICENSE TRANSIENT TRADERS AND PEDDLERS

The Council of the Town of Sackville, under authority vested in it by the Municipalities Act, enacts as follows:

TITLE

 This By-law may be cited as the Transient Traders and Peddlers By-Law.

INTERPRETATION

- In this By-Law;
 - (a) "transient trader" means:
 - (i) a person doing business in the Town who, not having resided in the Municipality for at least three (3) months next preceding the time of the commencement by him of such business, offers services, goods or merchandise for sale in any manner, and whether conducted by himself, or agent, or a licensed auctioneer;
 - (ii) a person ceases to be a transient trader after having operated a business at a fixed location in the Municipality for a period of two (2) calendar months.
 - (b) "Peddler" means any person who peddles or hawks, or carries from place to place for peddling or hawking, goods or merchandise.
 - (c) "Person" includes a body corporate and politic, and the heirs, executors, administrators or other legal representatives of a person. A "person" also means either a man or a woman and in any place where the masculine gender is used it shall include the feminine if the context so requires and where the feminine gender is used it shall include the masculine if the context so requires.
- 3. Every Transient Trader or Peddler shall pay to the Town Treasurer, a license fee of One Hundred (\$100.00) dollars before commencing business in the Town.
- 4. Except as herein provided, no person, not being a resident or ratepayer of the Town shall carry on or engage in any business, industry, calling, profession or occupation or peddle, hawk or carry from place to place for peddling or hawking any goods or merchandise within the Town unless that person obtains a license therefore.

- 5. The Town Clerk is hereby authorized to grant to any person a license under the seal of the Town to carry on or engage in any business, industry, calling, profession or occupation within the Town upon payment by such person to the Town Treasurer.
- 6. A license issued under this By-Law shall continue in force for a period of fourteen (14) consecutive days from the date of issue therefore.
- 7. This By-Law does not apply to a person who is:
 - (a) An employee of a telephone or electric power company, who is required in the course of his duties to carry on his occupation temporarily within the Town;
 - (b) An insurance agent, broker or adjuster who is required to pay a license fee under the Provisions of the Insurance act.
- 8. Every person who violates any provision of this By-Law shall be guilty of an offence and on summary conviction, is liable to a penalty of not less than One Hundred (\$100.00) Dollars and not exceeding Two Hundred (\$200.00) Dollars for each day that the person is in violation of this By-Law.
- 9. By-Law Nos. 49 and 103 are hereby repealed.
- 10. This By-Law comes into force on the date of final passing thereof.
