## PROPOSAL

To have Council authorize the purchase of chemicals for the Sackville water treatment plant for 2026.

## BACKGROUND

Chemicals are required for the treatment of the raw water including disinfection, pH adjustment and corrosion protection. Veolia is contracted to operate the treatment plant for Tantramar and they order, receive and apply the chemicals as required. Receiving the chemicals requires Veolia to dispatch personnel to the treatment plant when they are not normally there.

## DISCUSSION

Purchase of chemicals is routinely done. For simplicity it is desirable to issue one purchase order for the calendar year for chemicals. The resulting amount exceeds \$25,000 and requires Council approval.

The chemicals are purchased by Veolia and may be from multiple vendors depending on pricing and delivery times, Veolia has established vendor relationships and preferred client pricing with select vendors where the savings are realized by Tantramar.

The chemicals to be purchased include the following. Pricing includes Veolia 10% mark-up. HST is extra. Chemical prices are valid to September 2026. A contingency has been shown to allow for chemical price increases and possible increased chemical consumption.

The amount and cost (about \$4,000) of chemicals for the Dorchester water treatment plant are significantly less and do not require Council authorization.
